THIS IS A RELAY RACE AND WILL REQUIRE AN ESCORT BOAT. EACH TEAM IS RESPONSIBLE FOR PROVIDING THEIR OWN ESCORT BOAT. NO TEAM WILL BE ALLOWED TO RACE WITHOUT AN ESCORT BOAT. ESCORT BOATS MUST HAVE A VHF RADIO OR CELL PHONE & PFDs ABOARD

WAIVER AND RELEASE OF LIABILITY

In consideration of being allowed to participate in any way in the 6th ANNUAL BIG ISLAND CHALLENGE RELAY, to be held April 20, 2002, I the undersigned, intending to be legally bound hereby for myself, my heirs, executors and administrators do waive and release any and all rights and claims for damages I may have against HAWAII ISLAND PADDLESPORTS ASSOCIATION, AMERICAN CANOE ASSOCIATION, its directors, members, and sponsors:

1. Agree that prior to participating, I will inspect the facilities and equipment to be used, and if I believe anything is unsafe, I will advise my team, coach or sponsor of such conditions and will refuse to participate.
2. Acknowledge and fully understand that each participant will be engaging in activities that involve risk of serious injury, including permanent disability and death, and severe social and economic losses which might result not only from my own, but also the actions, inactions or negligence of others, the rules of play, or the condition of the premises or of any equipment used. Further that there may be other risks not known to me or not reasonably foreseeable at this time.
3. Assume all the foregoing risks and accept personal responsibility for the damages following such injury, permanent disability or death.
4. Release, waive, discharge and covenant not to sue BIG ISLAND CHALLENGE, HAWAII ISLAND PADDLESPORTS ASSOCIATION,, its respective organizers, administrators, directors, agents, coaches, and other volunteers or employees, if any, of the organization, other participants, sponsoring agencies, sponsors, advertisers, and if applicable, owners and lessors of premises used to conduct the event, including the County and State of Hawaii, (hereinafter referred to as "releasees"), from demands, losses or damages on account of injury, including death or damage to property, caused or alleged to be caused or alleged to be caused in whole or part by the negligence of the releasee or otherwise.
